

Presidential Election Forecast Shows *Biden as a Strong Favorite*



The Growth of \$1 Invested in the S&P 500 Is Largely Positive *Regardless of Which Party is In Office*













State Governor Races *Favor Republicans Keeping a Majority*




Potential SCOTUS Impact of Hon. Amy Coney Barrett
