Product Description

Dynamic Fixed Income ETF Advantage seeks to provide current income to the portfolio primarily through investments in fixed income securities.

The portfolio's 2-3 year investment horizon typically results in a significant percentage of portfolio assets allocated to relatively lower risk fixed income investments, enhanced by allocations to higher risk fixed income assets with higher yields and some long-term return potential. The specific mix between lower risk and higher risk fixed income assets is determined through RiverFront's Price Matters® framework, which allocates more to higher volatility assets when yields are relatively high and reduces these allocations when yields are less attractive to us on a long-term basis.

Tactical strategies typically seek to add value by shifting the portfolio among fixed income asset classes based upon the shorter term momentum in their economic fundamentals, market conditions and technical pricing movements. The relatively short 2-3 year time horizon of this portfolio, however, dictates that short-term, defensive measures may need to be emphasized in order to protect portfolio values.

COMPOSITE CHARACTERISTICS:

The ETF Dynamic Fixed Income Composite (Composite) was created on January 1, 2014. The Composite Benchmark is the Bloomberg US Aggregate Bond Index TR, which is an unmanaged index that covers the investment grade fixed rate bond market with index components for government and corporate securities, mortgage pass-through securities, and asset-backed securities.

The ETF Dynamic Fixed Income composite is designed for investors seeking a total

return (interest income and potential price appreciation) that aims to outpace the Bloomberg US Aggregate Bond Index while investing in a diversified portfolio of income-oriented ETFs and closed-end funds (CEFs). In an attempt to outperform its benchmark, the portfolio managers will employ a combination of investment strategies such as sector rotation, yield curve and interest rate anticipation, and security selection, depending upon market conditions. The portfolio may invest in a wide variety of income oriented ETPs and CEFs including Treasuries, Corporate Bonds, Agencies, Mortgage Backed Securities (MBS), Convertible Bonds, High Yield Bonds, Emerging Market Bonds, Foreign Bonds/Currencies, Preferred Securities, Floating Rate Securities and Asset Backed Securities (ABS).
